DECISION OF THE EXECUTIVE COMMITTEE

30/01/2023

SUBJECT: ACTIVITIES AND CHARGES SUBJECT TO ECONOMIC REGULATION. 2023 CHARGES CONSULTATION PROCESS.

PUBLICATION: ANA Website

Pursuant to Decree Law no. 254/2012 of 28 November, as amended by Decree Law no. 108/2013 of 31 July, and the public airport service Concession Contracts signed between the Portuguese State, ANA Aeroportos de Portugal S.A. (ANA) is the concessionaire of the domestic airports located on mainland Portugal (Lisbon, Porto, Faro and Beja) and in the Autonomous Region of the Azores (Ponta Delgada, Santa Maria, Horta and Flores), and the airports of the Autonomous Region of Madeira (Madeira and Porto Santo).

On 30 September 2022, ANA formally launched the due consultation process on the charge schedule for regulatory activities for 2023 with the Users of the Lisbon Group airports (Lisbon, Beja, Ponta Delgada, Santa Maria, Horta, Flores, Madeira and Porto Santo), Porto Airport and Faro Airport.

This consultation process was suspended on 24 October 2022 by decision of ANAC (Letter no. 93/PCA/2022), and resumed on 16 December with the reformulation of the charge schedule proposal for 2023, under the terms and in accordance with the decision of the Regulatory Authority, although ANA does not agree with what was determined, and reserves the right to use all available means to defend its interests.

With the declared objective of starting the 2023 charge schedule applicable to airport activities subject to economic regulation on 1 April 2023, the consultation process timetable complied with the deadlines determined in the legislation in force. The consultation procedure begins more than 120 days after the entry into force of the new regulatory charges, with the additional deadlines that resulted from ANAC's decision, and extended the deadline for sending Users' comments until 16 January 2023, as requested by the latter.

To simplify procedures and allow an integrated overall understanding of the updates to the regulatory rate system, a single process was used to consolidate rate consultations for 2023 charges applicable to traffic and ground handling activities subject to economic regulation, security activities comprising concessionaire revenues and the activity of assisting passengers with reduced mobility (PRM), as in previous rate consultation processes.

In this process, the users of the above airports, their representatives or associations have been consulted, and the Autonomous Regions of the Azores and Madeira have been heard, pursuant to and for the purposes of Articles 71 and 79 of Decree Law no. 254/2012.

All comments received from users, their representatives or associations and from the Autonomous Region of the Azores were analysed and addressed in sequence, with ANA having produced and sent its regulatory charges

consultation process file to all those who participated in the consultation process and also to ANAC, thereby fully

complying with the provisions of Article 71(4) of Decree Law no. 254/2012.

At the end of the consultation process for the 2023 charge schedule applicable to activities subject to economic

regulation pursuant to Decree Law no. 254/2012 and Annex 12 to the Concession Contract, it is important to

note that:

a. In accordance with what is defined in Annex 12 of the Concession Contract and with what is determined

in the ANAC Decision notified by Letter no. 93/PCA/2022, the Regulated Revenue Price Cap (RRPC) for

2023 of the Lisbon Group will have a variation in accordance with the HICP¹ + 2%, and the regulatory

charges at Porto and Faro airports will change in line with the HICP1, with the exception of PRM and

Security charges, which are derived according to their cost base, changes to which cannot be offset in

the other regulatory charges at Porto and Faro airports.

b. The variation in collective regulatory charges at ANA results, in annual terms, in an average increase of

3.86%, distributed as follows among the network's various airports:

Lisbon: 7.59%

Azores: 4.33%

Madeira: 5.88%

Porto: -5.24%

Faro: -5.26%

Beja: 5.34%

c. In absolute terms, the increase in regulatory income per terminal passenger is +€+0.41 in the ANA

network, distributed as follows among the airports:

Lisbon: €0.96

Azores: €0.31

Madeira: €0.70

Porto: €-0.43

Faro: €-0.43

Beja: €16.34

d. In absolute terms, the changes in revenue proposed for airports in the ANA network do not jeopardise

their rate competitiveness; in the case of Porto and Faro airports, on the contrary, the 43 percent

reduction in revenue per terminal passenger in the ANA proposal, together with other support and

development measures, will even strengthen the competitiveness of these airports.

- e. For 2023, ANA will implement a modelling of the landing charge according to aircraft noise level, with the specific purpose of encouraging use by less noisy aircraft with better environmental performance. The proposed modelling has the following guidelines:
 - Non-discriminatory, universal application to all ANA network airports and all users.
 - Zero impact in terms of revenue generated for ANA and at each of the groups with revenue ceilings in the regulatory model, i.e. the Lisbon Group, Porto Airport and Faro Airport.
 - Underlying use of the ICAO recommendations in Annex 16 and noise level ranking system recommended by the ACI.
- f. Aircraft will be grouped into eight classes, each having an underlying factor entailing a bonus or a penalty vis-à-vis the amount of the landing charge previously determined by the aircraft's MTOW.
- g. The RRPC₂₀₂₃ of the Lisbon Group airports is based, as determined by ANAC (Official Letter no. 93/PCA/2022) on the RRPC₂₀₂₂ determined in the 2022 charges proposal, and not on the RRPC calculated according to the actual terminal passengers in 2022. It is therefore necessarily of a provisional nature, with the adjustment mechanism for its update having been determined by ANAC in its Decision (Official Letter no. 93/PCA/2022), and published in the additional information to the consultation process disclosed by ANA.
- h. ANA's charge schedule proposals for the charges for security activities comprising concessionaire revenues and the activity of assisting passengers with reduced mobility (PRM) comply with the obligations and calculation conditions established in Decree Law no. 254/2012 and entail, in both cases, setting a network charge collectively for all ANA network airports.
- i. At the smaller airports, in particular Madeira's airports, the 2023 rate proposal complies with point 8.7 of Annex 12 of the Concession Contract, with the regulated revenue per passenger at Madeira's airports being lower than that set for Lisbon Airport.

In view of the above,

Having held the 2023 rate consultation process and considering the participation of users, their representatives and associations, and the Autonomous Regions of the Azores and Madeira, pursuant to Article 7(1)(b) and Article 71(4) of Decree Law no. 254/2012, and in accordance with the terms and legal and economic grounds in all documents comprising an integral part to this decision, the following has been decided:

1. To approve the review of the charge schedule proposals for regulatory activities charges, established in accordance with ANAC's Decision, to be applied in 2023 at the Lisbon, Porto and Faro Group airports.

- 2. To approve the maintenance charge schedule proposals for 2023 for the charges applicable to safety and assistance activities to PRM that constitute revenue for the Concessionaire, and submit them, respectively, for government decision and publication under the terms of Article 52(2) of Decree-Law 254/2012, and for approval by the Board of Directors of ANAC, under the terms of Article 61(3) of Decree-Law no. 254/2012.
- 3. To approve the entry into effect of charges for regulatory activities at ANA network airports beginning on 1 April 2023.

This ANA rate decision for 2023 has been made with exemption from a hearing of interested parties, pursuant to Article 124(1)(d) and (1)(e) of the Code of Administrative Procedure passed by Decree Law no. 4/2015 of 7 January, and has been implemented per the regulatory charges tables comprising Annex I to this decision.

The following is also decided:

- i) This decision will be published, by 30 January 2023, on ANA's website, together with the tables of approved charges (Annex I), pursuant to Article 71(5) of Decree Law no. 254/2012; and also,
- to this decision, will be sent to all users who participated in the consultation process and to ANAC, thereby fully complying with the provisions of Article 71(4) of Decree Law no. 254/2012.
