

ENVIRONMENT POLICY ANA PORTUGUESE AIRPORTS⁽ⁱ⁾

ANA Portuguese Airports S.A. (ANA) is responsible for the management of a set of airport infrastructures of vital importance for the national economy and for the local economies surrounding the airports.

ANA, aware of its environmental and social responsibilities, is committed to minimizing the impact resulting from the development of its activity, both on the environment and on local communities, impacts that may have different characteristics in view of the traffic and location of each of the airport infrastructures under its management.

This Policy applies only to ANA and does not cover any of its subsidiaries or associated companies. It applies to all activities under ANA's direct responsibility, covering the aviation and non-aviation business segment developed within the scope of the concession of the airports under its management.

All elements of the organization are responsible for developing their activity ensuring compliance and implementation of this Policy. It is up to the company's top management to approve the strategic lines and ensure the integration of environmental commitments into the company's overall management, with the ultimate responsibility for ensuring their implementation across the organisation.

ANA considers that it is up to it to adopt and disseminate clear guidelines for the future and to promote awareness of environmental issues among all airport operators, users and workers.

ANA commits to act in terms of environmental protection, monitoring, controlling, preventing and reducing its impact on local communities, surrounding areas and the environment in general, making every effort to ensure responsible action in this matter, assuming the following environmental policy, which will respect the sustainable development principles, seeking a balance between the environmental, social and financial components:

1. Systematically apply the principles of sustainable development in the planning, design, construction, operation and decommissioning of facilities, systems and services;
2. Lead change processes with its employees and business partners in order to achieve environmental improvements, resulting from concerted action and effective communication of policy and objectives in this area;
3. Develop management systems in this regard and involve all staff to ensure that environmental factors are included and weighed up in the analyses leading to decision-making;
4. Establish a frank and open dialogue with local communities and others affected by the environmental impact of its operation, seeking and discussing solutions that consider the viability and socio-economic balance of the development of the activity;

5. Continuously improve the company's integrated management system, in order to ensure the improvement of its environmental performance as a whole, establishing comparisons with analogous situations, being ambitious in the defined objectives, promoting the audit and annual reporting of the results achieved and allocating the indispensable financial resources;
6. Ensure compliance with legislation, and other applicable compliance obligations, as a minimum objective and performance required at an environmental level.

The priority areas of action at ANA, and adapted to the existing situation in each location, progressively consider the entire value chain, and include the adoption of strategies oriented to:

- The energy efficiency promotion, the use of renewable energies and more sustainable energy sources, the monitoring and reduction of greenhouse gas emissions, contributing to the decarbonisation of operations and accelerating the sector transition through the involvement of its partners and the commitment to innovation.
- The adoption of strategies to adapt its infrastructures and operations to climate change, seeking to map, assess and manage climate, physical and transition risks and opportunities, in the short, medium and long term, making the company and its infrastructures, operations and people increasingly resilient.
- Monitoring and minimizing water consumption, ensuring the sustainable and efficient management of water resources, including: promoting the rational use of water in all airport operations; supply from sustainable sources, favoring public supply systems or properly licensed on-site extraction systems; the treatment and reuse of wastewater (rainwater and grey water), whenever technically and monetarily feasible; monitoring and mitigating the risks of water stress in regions where there are airport infrastructures under its management; continuous monitoring of consumption and loss control.
- The control of potentially polluting emissions to air, soil and water resources, including: the prevention and control of air, water and soil pollution; the identification and monitoring of the main pollutants associated with airport activity; the minimisation and substitution of substances of concern and the phasing out of substances of very high concern (SVHC), in accordance with the REACH Regulation and other applicable European framework; the prevention of environmental incidents and emergencies, ensuring immediate and effective action to limit impacts on the environment and communities.
- Promoting the reduction, reuse and recycling of waste. ANA is committed to reducing waste production, increase recovery and recycling rates and ensure that waste is properly sent for treatment, in accordance with legislation and best environmental practices. It also commits to promoting the transition to the use of secondary resources and to ensure a sustainable supply of renewable resources.
- Noise management, assuring the sound levels monitoring and the implementation of mitigation measures, with a view to reconciling the development of airport operations with the health and quality of life protection of the surrounding communities.

- The preservation of biodiversity, promoting the protection of ecosystems and species found in areas within the sphere of influence of the airports under its management, without ever compromising aviation safety. ANA is committed to identifying, preventing, mitigating and, where necessary, remedying impacts on species, habitats and ecosystems, as well as managing relevant pressure factors, including land-use changes, pollution and invasive non-native species.

The Environmental Policy is publicly available to all interested parties through ANA's institutional channels, namely the corporate website and internal communication platforms. This Policy is periodically reviewed to reflect operating conditions evolution, applicable regulations and international environmental management best practices.
