DELIBERATION

SUBJECT: ACTIVITIES AND CHARGES SUBJECT TO ECONOMIC REGULATION. 2019 CHARGES CONSULTATION PROCESS

BASIC DOCUMENTS: C.I. no 670563, de 05-11-2018

DISCLOSURE: ANA's website

Under the terms of Decree-Law 254/2012, published on 28th November, changed by Decree-Law 108/2013 published on 31st July, and of the Concession Contracts for the airport public service established with the Portuguese Government, ANA Aeroportos de Portugal SA (ANA) is the Concessionaire of national airports in Portugal's mainland (Lisbon, Porto, Faro and Beja), in the Azorean Autonomous Region (Ponta Delgada, Santa Maria, Horta and Flores) and in the regional airports of the Madeira Autonomous Region (Madeira and Porto Santo).

With the stated objective of setting 11th January 2019 as the date for entry into effect of the 2019 charges applicable to airport activities subject to economic regulation, ANA formally launched, on 10th September2018, the corresponding consultation process for the Users of the Lisbon Group airports (Lisbon, Beja, Ponta Delgada, Santa Maria, Horta, Flores, Madeira and Porto Santo), Porto airport and Faro airport.

The consultation procedure began more than 120 days before the new regulated charges come into effect, thus meeting the legally established deadline.

As was ANA's common practice during previous consultation processes, to simplify procedures and in order to enable a full and overall understanding of the update proposed for the charges system subject to economic regulation, ANA integrated in one sole process three different charges consultations relative to the 2019 charges

- a) for traffic and ground handling activities subject to economic regulation;
- b) Security activities that constitute Concessionaire revenue; and
- c) the activity of Assistance to Passengers with Reduced Mobility (PRM).

In this charges consultation for charges subject to economic regulation to be applied in 2019, the Users of the abovementioned airports, and their representatives or associations were consulted, and the Autonomous Regions of the Azores and Madeira were heard, under the terms and for the purposes established in Articles 71 and 79 of Decree-Law no. 254/2012.





All the opinions received within the legal deadline from the Users, their representatives or associations, as well as from the Autonomous Region of Madeira were carefully analysed, and ANA forwarded their respective comments

to all the entities consulted and to the Regulating Authority (National Authority for Civil Aviation - ANAC), thus,

fulfilling what was established in Article 71 (4) of Decree-Law no. 254/2012.

As duly disclosed to the Users, the 2019 charges consultation for regulated traffic and ground handling activities to

be applied at the Lisbon Group of airports (Lisbon, Ponta Delgada, Santa Maria, Horta, Flores, Madeira, Porto Santo

Airports and Beja Civil Terminal) has been suspended as per ANAC's decision.

Therefore, in finalizing the 2019 charges consultation process for traffic and ground handling activities subject to

economic regulation to be applied at the Porto and Faro airports, it is important to consider that:

a. With the publication of the actual HICP (28 countries of the European Union), reported in August 2018, at

1.8%, instead of the 1.6% initially mentioned in the consultation process, ANA, maintaining all the

previously forecast modulations and the methodology defined in Annex 12 of the Concession Contract,

recalculated the regulated revenue cap for the Porto and Faro airports, the details of which are mentioned

in the attached document (Annex I);

b. As a result, the charges proposal for the Porto and Faro airports was adjusted by applying the HICP reported

in August 2018 of 1.8%.

The Table of charges that are subject to economic regulation is attached and is an integrated part of this

Decision (Annex II);

c. The variation of the set of regulated charges translates, annually, into the following average increase per

airport:

Porto: 1.40%

Faro: 1.49%

d. In absolute terms, the increase in regulated revenue per terminal passenger per airport is as follows:

Porto: 0.11€

Faro: 0.12€

e. The absolute evolutions proposed do not constitute an excessive variation in charges, since they are below

the inflation rate (1.8%) and - also important - they do not compromise the ANA network airports' activity

and charge competitiveness;

- f. In terms of modelling of the charges structure, the actions proposed by ANA aim, at the Porto Airport, to continue the charges convergence process for the Non-Schengen and International segments and to combat seasonality by reducing the landing charge during the IATA Winter season.

 In the case of the Faro airport, the charges modelling proposed aims to continue combating seasonality during the IATA winter season by only updating the passenger service and landing charges in the IATA Summer season;
- g. The RRMM₂₀₁₉ set by ANA for the Porto and Faro airports are inevitably grounded on the traffic forecasts for 2019, so they are, necessarily, of a temporary nature. In this measure, they are susceptible to possible correction in light of the real traffic ascertained for 2019, as well as, in the case of a higher traffic performance than foreseen, carrying out the adjustments established in Annex 12 (5) of the Concession Contract.

Relative to the charges consultations meanwhile concluded regarding security activities that provide revenue for the Concessionaire and PRM assistance activities, it was believed suitable to maintain the charges proposal presented for these two charges subject to economic regulation, which respects the obligations and calculation constraints for these charges stipulated in Decree-Law no. 254/2012 and which involves, in both cases, setting an identical network charge for the group of ANA Network airports.

Given all the above,

Once the 2019 charges consultation process is carried out with the participation of the Users, their representatives or associations and also the Autonomous Regions of Madeira and the Azores, it is decided, pursuant to paragraph b) of Article 7 (1) and Article 71 (4) of Decree-Law no. 254/2012, and waiving the hearing of the interested parties under the terms of paragraphs d) and e) of Article124 of the Administrative Procedures Code, approved by Decree-Law no. 40/2015, of 7 January, and under the terms and with the legal and economic grounds included in all the basic documents that are an integral part of the present Deliberation, to:

- 1) Approve maintaining the 2019 charges proposals for the charges applicable to security activities that constitute Concessionaire revenue and the PRM assistance activity, subjecting them, respectively, to the decision and governmental publication and to approval by ANAC's Board of Directors, under the terms and for the purposes established in Article 52 (2) and Article 61 (3) of Decree-Law no. 254/2012.
- 2) Approve the review of the charges proposals relative to the Porto and Faro Airports in light of the evolution of the HICP published by Eurostat reporting to August 2018 relative to the amount indicated initially in the charges consultation process launched on 10 September 2018.
 Review the regulated revenue price cap for the Porto and Faro airports, detailed in an attached document (Annex I).





Approve the 2019 charges proposal on the charges for traffic and ground handling activities subject to economic regulation to be applied at the Porto and Faro Airports, producing effects as at 11 January 2019. ANA's charges proposal can be found in the Table of regulated charges that comprise Annex II to the present Decision.

Furthermore, it is decided that:

- i) The File on the 2019 regulated charges Consultation Process for the Porto and Faro airports be sent to all the Users that participated in the consultation process, as well as to ANAC, comprising Annex III to the present Decision, thus, complying with that set forth in Article 71 (4) of Decree-Law no. 254/2012; and, also, that
- ii) This Decision be published on ANA's website by 9th November 2018, along with the approved Table of Charges Annex II of this Decision as required in n. 5 of Article 71 of Decree-Law 254/2012.
